Terms and Conditions

Guardians of the S.E.A.A. Card

General

1. Guardians of the S.E.A.A. Card is a membership programme run by Resorts World at Sentosa Pte. Ltd. (UEN: 200502573D) (“RWS”).
2. These Terms and Conditions govern the Guardians of the S.E.A.A. Programme (the “**Programme**”), and RWS’s relationship with the Members of the Programme.
3. By subscribing to the Programme, the Member acknowledges that he/she has read, understood and accepted these Terms and Conditions.

Application and Membership

4. Term: The term of the Guardians of the S.E.A.A. Card membership shall commence from the date of RWS’s (i) receipt of full payment of the Application Fee (hereinafter defined in Clause 7) *and* (ii) grant of approval of the application, for a one (1) year period (“Term”). The Term will be automatically renewed for an additional one (1) year period (“Renewed Term”) and thereafter any Renewed Term(s) will be automatically renewed for additional one (1) year period(s), unless the Member notifies RWS in writing no later than thirty (30) days before the expiry of the Term or Renewed Term of his/her intention to terminate the membership.
5. Age requirement: Applicant must be at least four (4) years of age. If the applicant is between four (4) and twelve (12) years old, he/she must be registered by and accompanied by his/her parent or legal guardian.
6. Enrolment fee: There is an upfront one-time S\$8 enrolment fee for the Guardians of the S.E.A.A. Card (hereinafter defined in Clause 10) purchased by the Passholder (the “Application Fee”).
7. Applications may be completed online at <http://seaa.rwsentosablog.com/guardians-of-the-seaa/>.
8. As a pre-requisite to applying for the Programme, applicants must provide RWS with all requested information and complete the application form as prescribed by RWS.

9. Applications may be declined at RWS's sole and absolute discretion.
10. Upon the approval of an application by RWS, Members will be issued with membership cards ("**Guardians of the S.E.A.A. Card**") to be collected on-site during the next registered event. S\$10 administrative charges will be levied for the replacement of lost, stolen or damaged Guardians of the S.E.A.A. Cards.
11. The Member is responsible for keeping membership information up to date, including relevant information such as contact numbers, mailing addresses and email addresses.

Terms for Privileges

12. The Programme, its privileges and its benefits are offered at the sole and absolute discretion of RWS.
13. Any privileges and/or benefits accrued by a Member are for the Member's benefit only, and are strictly non-transferable and non-assignable.
14. Members may purchase One-Day Tickets to S.E.A. Aquarium at a discounted rate that may be offered from time to time.
15. One-Day Tickets must be purchased on-site at any Attractions Ticket Booths.
16. Members may purchase up to a maximum of six (6) One-Day Tickets per day, for each of the discounted tickets to S.E.A. Aquarium.
17. Privileges under Guardians of the S.E.A.A. Card shall be valid for twelve (12) months from the date of RWS's approval.

Suspension and Termination of Membership

18. RWS reserves the right, in its sole and absolute discretion, to immediately and without prior notice, suspend and/or terminate a Member's membership.

Personal Data

19. The applicant hereby consents to RWS to collect, use and disclose his/her personal data as disclosed to RWS for the Member's application, all things ancillary to his/her application, and the Programme.

Miscellaneous

20. RWS reserves the right, in its sole and absolute discretion, to amend, delete, modify or vary these Terms and Conditions, the Programme, and its privileges and benefits, including the cancellation of the Programme, without prior notice and without compensation to the Members.
21. RWS shall not be liable for any loss or damage resulting from or relating to the use of the Programme.
22. Members shall fully indemnify and keep indemnified RWS against all claims, damages, costs and/or expenses made against or incurred by RWS and its directors, officers, employees, affiliates, subsidiaries, agents and/or tenants arising from or relating to, without limitation, Members' use of the Programme or any breach of these Terms and Conditions.
23. A person who is not a party to any agreement governed by these Terms and Conditions shall have no rights under the Contracts (Rights of Third Parties) Act (Cap. 53B) to enforce any of these Terms and Conditions.
24. These Terms and Conditions shall be governed by the laws of Singapore. The courts of Singapore shall have exclusive jurisdiction over any disputes arising from these Terms and Conditions, including the validity and enforceability thereof.
25. RWS reserves the right, in its sole and absolute discretion, to interpret, apply and communicate these Terms and Conditions. All decisions made by RWS shall be final and conclusive in each case.
